Thank you for your interest in joining the Warren County Chapter of The Izaak Walton League of America (IWLA)! By completing and submitting your application, you are joining a group of dedicated individuals who strive to preserve and protect the natural habitat of our region and promote the responsible use of that habitat for a full range of outdoor sports and activities.

Being a member gives you access to all the park facilities and opportunities to protect our environment and give back to the community. As an active member, you can also bring family and friends with you to the Park as guests, provided you're with them the entire time. You may apply for one of two types of membership - Individual and Family. An Individual Membership is for one person 18 years of age or older. A Family Membership is for two individuals who reside at the same residence that are 18 years of age or older.

Annual memberships run from Jan 1st through Dec 31st. The annual dues payment includes Chapter, State (Division), and National dues. An Individual Membership is \$101.00 and a Family Membership is \$154.00. There is a single, one-time \$35 initial application fee for each type of membership. Payment does not need to be submitted with the application. Please complete the application legibly and completely, making sure that you put your signature in all required spaces. Complete a separate "Hold Harmless" form for yourself and, if applicable, the other named member on a Family Membership.

Once I receive an application:

- Each applicant will undergo a background check of State and Federal criminal and sex-offender databases.
- The Chapter Board will vote on your application, and then you will then be required to attend the next Chapter Membership Meeting. You will be introduced to the membership in attendance and then the members will vote on your application.
- Once approved by the membership, you'll be contacted for dues payment.
- You will be invited to attend a new-member orientation of the facilities and to receive a new-member packet (Current By-Laws; information on the Warren County Chapter Park; a copy of the Park Policy and Chapter Guidelines; a temporary IWLA membership card; and, most important, the combination for the locks that secure the Park Gate and the House).
- Your official membership card(s) will be sent to you as soon as it is issued by IWLA, usually within a week or two.

I will keep you informed as your application moves through the system, especially when your application is scheduled to be voted on.
